A meeting of the Board of Regents was held pursuant to the call of the President. Present: H. G. Blasdel and C. N. Noteware.

on application of S. S. Olin for S.W. 1/4 of N.E. 1/4 and S.E. 1/4 of N.W. 1/4 of Section 7, J15 N. R.21 E., 80 acres under 500,000 Acre Grant, being in total 120 acres.
