June 25, 1903

The Board of Regents met in Special meeting Thursday, June 25, 1903, at 9:30 A.M., a full Board being present.

On motion of Regent Booher, seconded by Regent Kirman, Mr.

Richard Brown was instructed to secure ten keys and a Master key for the Girls' Cottage, one key to be given to each student on the deposit of 25 cents, same to be returned to said students when the key was given up.

President Stubbs placed in nomination Miss Francis E. Short for Instructor in English and Mistress of the Girls' Cottage. Upon motion of Regent Kirman, seconded by Regent Booher, Mrs. N. W. Blume was requested to hand her resignation to the Board to take effect August 31, 1903, Regent Evans voting against the request.

Superintendent Brown was instructed to have all leaks in the gas pipes in the Girls' Cottage repaired at once.

Upon the recommendation of President Stubbs, Professor Robert
Lewers was appointed acting President until September 1, 1903,
or in the absence of President Stubbs and Dean Thurtell (now
acting President). Carried.

Upon motion of Regent Kirman, seconded by Regent Booher, the contract of W. H. Lyon for cases in the Mining building submitted in his bid June 15, 1903 for \$102 was accepted.

Upon motion of Regent Kirman, seconded by Regent Booher, a verbal lease for use of baseball grounds be accepted from Regent Evans for one year, and the University in return extend to the family and their friends complimentary tickets to all the privileges of the games.

Board took a recess to 4 o'clock P.M. this day.

The bid of John Barrett for furnishing granite coping for stone wall at the entrance to the grounds at \$3.50 a running foot complete in the wall was accepted.

It was moved, seconded and carried that no person except students be granted the privilege of using the University Hospital.

The nomination of President Stubbs that Miss Frances E. Short to the position of Instructor in English and Mistress of the Girls'

Cottage at an annual salary of Six Hundred dollars, payable monthly from September 1, 1903, was approved.

The bid of Daniels & Steinmetz to furnish all the supplies and do all the work in the Girls' Cottage, Morrill Hall, Stewart Hall and Lincoln Hall according to specifications on file in the Regents' Office for the sum of \$318.75 to the satisfaction of the Superintendent of Buildings and Grounds and the Board of Regents was accepted.

The bid of P. Hailand for painting the buildings as follows was accepted. (Nothing follows.)

No further business, the Board adjourned to meet at the call of the Chairman.
