The President recommended that the Board of Regents adopt this rule which is to apply in case applications for Dormitory privileges either for men or women are in excess of the accommodations of the University, preference shall be given as follows:

- 1st. To all students who have been previously enrolled in the University of Nevada;
- 2nd. Among new student applicants preference shall be given to those whose families reside in Nevada.

The President recommended the adoption of the following student enrollment limitation policy and Mr. Pratt moved its adoption:

That, from and after September 1, 1920, the University of Nevada shall not, during either semester or any University year, receive students whose families or whose guardians reside outside the State of Nevada, or who, if they have been living independently of family or guardian, have themselves been residing outside the State of Nevada, to a number exceeding 50% of the total number of students from Nevada enrolled during the preceding University year, September to May inclusive, provided

- (a) That the above limitation shall not be put into effect until the total enrollment of the University has reached 600 for a given semester, or when it will reduce the enrollment below 600; and
- (b) That the above limitation policy shall not operate to exclude any students from outside the State of Nevada who desire to enroll in the regular courses for Mining Engineers and who are fully qualified for entrance or advanced standing in the Mackay School of Mines.

President Clark briefly outlined the University Building Program which he will submit to Mr. Mackay at Mr. Mackay's request.

President Clark recommended that the cost of the Book of the Oath should be paid from the Regents Contingent Fund. Vote:

Judge Cheney asked for a statement of the personal proposition of which President Clark spoke to the Board at its April meeting. President Clark made the statement as requested.

Judge Cheney told the members that Mr. Ed Vanderleith had word from some woman's organization at Fallon with which his sister had worked to the effect that they were going to establish a fund of \$500 this year to be known as the Emma Vanderleith School Fund and that they expected to add \$500 to it each year.

President Clark stated that there was some doubt in the minds of the members of the Honorary Board of Visitors as to whether their existence was at all justified and if so, whether it would not be better for them to meet at some time when the University was in session rather than at Commencement time. Any change in the time of meeting would have to be a matter for legislative action inasmuch as Commencement Week is the specified time named in the statute creating this Board of Visitors. If any change were made in the law, it might be well to have it amended so that the traveling expenses of the Board members might be paid by the State, as well as their entertainment expense while in Reno.

The Board then adjourned its regular meeting until 3 o'clock on Wednesday afternoon and went into executive session.
