REGENTS MEETING May 9, 1936

President Clark presented the following recommendations of Director Doten of the Agricultural Experiment Station and recommended their adoption by the Board:

- a. Marjorie Howes, Clerk in Soil Fertility Department, to be advanced from \$900 to \$960 per year.
- b. Golamae Johnson, Librarian and Station Secretary, to be advanced from \$1500 to \$1620.

- c. M. R. Miller, Chemist, to be advanced from \$3450 to \$3600.
- d. V. E. Spencer, Chemist, to be advanced from \$3450 to \$3600.
- e. S. A. Lough, Chemist, to be advanced from \$800 to \$1200 on Station funds.
- f. Elmer Bogart to be elected to have charge of livestock experiments at Fallon at a salary of \$1800 per year to succeed Milton Miller, resigned, service and salary to be effective from June 1, 1936. Mr. Bogart will receive his B. S. in Animal Husbandry from the University of California this month.

President Clark recommended that Dr. S. A. Lough should receive also \$1800 per year from General University funds, beginning July 1, 1936, making his total salary from July 1, 1936, \$3000 per year.
