Dr. Hartman advised the Board of the return of the Postal bonds to the University, and told the Board that Senator Mc Carran and Congressman Scrugham both reported there was no foundation in fact to the rumored removal of the Rare and Precious Metals Mines Experiment Station from our Campus.

Dr. Hartman read Dean Butler's letter of April 25th, whose closing sentence is, "I also wish to compliment you upon the improvements in the Mechanical and Electrical Engineering curricula that

have been made during the past two years."

Dr. Hartman announced the Ginsburg scholarship award of a watch at the beginning of the 2nd semester to the man of the Sophomore Class, who, having completed the work of 3 semesters has an outstanding record among the men of his Class.

On motion of Mr. Ross, Dr. Hartman's recommendation that F. L. Bixby be Acting Head of the School and Department of Civil Engineering for a year (or two), beginning with Mr. Boardman's retirement September 1, 1939, was approved. Carried unanimously.

The President was directed to ask Dean Mack to make a written report to him concerning the Convention of Deans of Women in Cleveland last February, to which the Regents covered her transportation.

On recommendation of Dr. Hartman, Mrs. Wardin moved for granting of a leave of absence without pay to Fred J. Collins, Assistant Professor of Economics, Business and Sociology, for the academic years 1939-41. Carried unanimously.

Dr. Hartman read Dean Mack's report of May 10th, 1939 concerning the Reno Fire Chief's report on conditions in Artemisia Hall.

Dr. Hartman recommended that Dean Mack's request of May 10th for additional toilet and shower facilities on the top 2 floors of Artemisia Hall be laid over for further investigation by the Building Committee of the Regents. Carried unanimously.

On motion of Mr. Williams, the Board authorized the payment of \$250 for 90 copies of the 1939 Artemisia, on assurance from Professor Hill that it is an exceptionally fine yearbook.

On motion of Mr. Williams, Mr. Hunt's letter to Mr. Ross of date May 12, 1939, was unanimously referred to the Executive Committee with power to act.

Dr. Church's proposal in his letter of April 5 that the Regents take up his life insurance policy of \$5000 in connection with the Art Gallery and Gardens, of which Judge Brown is Director for the University, was, on motion of Mr. Williams, by a unanimous aye vote, referred to Judge Brown with request that he give the Regents his advice at their June meeting.

Dean Stewart appeared before the Board in answer to their summons and Chairman Ross, speaking for the Regents, asked him questions concerning the possibility of closer cooperation between the College of Agriculture, the Experiment Station and the Extension Division, stating that the College of Agriculture and not the other two branches of the work in Agriculture is under criticism. At the conclusion of the exchange between Mr. Ross and Dean Stewart, Dean Stewart was instructed to work with Dr. Hartman to see if it were not possible to develop a course that might strengthen the courses offered in the College of Agriculture, this being a desirable thing to do, and that this be done at as early a date as possible.

Dr. Hartman advised Regents that Walter Palmer and Dr. Gianella had been fairly cooperative and expressed themselves as satisfied in whatever cut in their respective salaries Dr. Hartman might find it necessary to make.

He also reported to the Board the steps he had taken in his attempt to bring about harmony within the Departmental staff of History and Political Science. The Regents accompanied the architect Mr. Fred J. De Longchamps to the northwest part of the Campus and there approved the site of the new Gymnasium as between Lincoln Hall and Hatch Station, the west line to be 20 feet east from the sidewalk or 50 feet from the curb.

On or about the 15th of June the Secretary was instructed to inquire of the respective Board members their preference for the June month-end meeting date and advise the Chairman so that he might fix the date of the meeting to suit the majority of those concerned.
