> UNIVERSITY OF NEVADA REGENTS MEETING April 12, 1958

The Board of Regents met on Saturday, April 12, 1958, in Room 205, Morrill Hall, University Campus. Present: Regents Anderson, Bastian, Broadbent, Elwell, Grant, Hardy, Sawyer, Thompson; Comptroller Hayden and Acting President Wood. Dr. Lombardi was unable to be present because of pressure of business. The meeting was called to order at 9:10 A.M. by Chairman Grant.

Reporters Bryn Armstrong, Jim Hulse, Bill Brown and Beryl Anderson covered the meeting. Present as observers were Mr. Tyler of the Legislative Counsel Bureau and Mr. Humphrey of the Nevada Taxpayers Association. Mr. Myneer Walker, President of the Alumni Association, and Mrs. Tyler were present in the afternoon.

Minutes of Previous Meeting

Motion by Mr. Broadbent, seconded by Mr. Hardy, carried unanimously that the minutes of the meeting of March 1, 1958 be approved.

2. Comptroller's Claims

Acting President Wood called on Mr. Hayden to present the list of claims for March 1958 as follows:

Rose Street with utilities and use of buildings and grounds personnel in maintaining the grounds, an expense account of \$300 per month against which he would be authorized to draw (with an accounting) for actual expenses incurred in connection with the duties of his office, and use of a University car. Vote:

Kendall Request

Dean Scheid submitted a report of the findings of himself and the members of his staff concerning the items in the Mackay School of Mines Museum received from Zeb Kendall, and now claimed by the son, A. L. Kendall, on the basis that they were not gifts, but loans. Included in Dean Scheid's report were affidavits from Walter S. Palmer, Vincent P. Gianella and Wm. I. Smyth that these items were received as gifts. Copies of letters from B. F. Couch to Vernon E. Scheid dated May 5, 1956, from Clarence H. Mackay to John A. Fulton dated May 7, 1928, from Zeb Kendall to H. E. Higgins dated April 7, 1928 and from John A. Fulton to Zeb Kendall dated December 10, 1928 were also included in

the report, bearing out the fact that these items were gifts to the Mackay Museum. On the basis of the affidavits, correpondence and other research concerning these museum pieces Dean Scheid requested that the items in question be retained as a part of the Mackay Museum.

Motion by Mr. Sawyer, seconded by Mr. Broadbent, carried unanimously that the report and recommendation be accepted, and that the request of Mr. A. L. Kendall for return of the articles be denied.

6. Gifts

The inspiration for the scholarship was Mr. Robert Emmett Perry, a close friend of Damon Runyon." Mr. and Mrs. Griss request also that the following statement be added: "If the income from the trust fund increases, additional funds and/or scholarships may be made available." (This

scholarship was accepted by the Board of Regents at the March 1, 1958 meeting.)

Motion by Dr. Anderson, seconded by Mr. Thompson, carried unanimously that the gifts be accepted and that the Secretary write an appropriate note of thanks to each donor.

7. Holmshaw Estate

Dr. Wood presented a check in the sum of \$57,116.30 received from the Executor of the estate of Alma M. Holmshaw "in partial payment and satisfaction of the amount to which the University of Nevada is entitled as one of the legatees pursuant to the provisions of the Last Will and Testament of Alma M. Holmshaw, deceased, as set forth in the Paragraph of said Will designated Nineteenth. These funds are accepted subject to all of the terms and conditions of said Paragraph Nineteenth, and shall be used and applied by the said University legatee for the establishment of a separate fund to be known as 'The Harry F. Holmshaw Scholarship'. It is further understood that the Regents or other qualified officials of the University shall in their full and uncontrolled discretion, make annual scholarship awards out of said funds to worthy and deserving students; that primary consideration shall be given to the need of the student or students receiving said awards rather than to their scholastic standing, and particularly to assist deserving students who would otherwise be unable to continue their studies in the University of Nevada; and that said awards shall be made regardless of race, sex, color or creed."

Motion by Mr. Thompson, seconded by Mr. Hardy, carried unanimously that Acting President Wood be authorized to sign the receipt for \$57,116.30 and that the Secretary write a note of appreciation to Mr. Sam Platt, Attorney, Mr. Hayes Schaffer, Executor, and Mr. F. M. Young, all of whom were helpful in the satisfactory handling of the estate.

Motion by Mr. Hardy, seconded by Mr. Broadbent, carried unanimously that the Harry F. Holmshaw Scholarship material be referred to the Chairman of the Committee on Scholarships and Prizes with the request that the Committee recommend the process for making the awards, and other necessary details in handling the scholarships, and that the recommendation be referred to the Board of Regents for final approval.

Mr. Thompson inquired as to this collection and other uncatalogued collections on the Campus, with a view to estimating the cost and determining the advisability of putting them in workable shape. Dr. Wood was asked to check into any such material for report to the Board of Regents.

9. Property Matters

Report was given by Mr. Hayden as follows:

- a) Blair Mr. Hayden had talked with Mrs. Blair concerning property arrangements with her, and the situation will be settled within the next 2 or 3 weeks in accord with action of the Board of Regents.
- b) Nielsen Mr. Nielsen has been asked for a survey of the boundary line of the property and of the sewer line, but he does not have them. Mr. Nielsen indicated that he is now willing to go into escrow and sell the property.
 - Motion by Mr. Broadbent, seconded by Mr. Hardy, carried unanimously that the Comptroller be authorized to take the necessary steps to acquire the property, and that the University supply the survey of boundary line and sewer line.
- c) Schmitt Negotiations with Mr. Schmitt have not resulted in agreement. Appraisal of the property is now being obtained.
- d) Capurro There was a minor error in the description of the property which held up its purchase following appropriation by the Legislature. Description is being checked by Mr. Robinson, Attorney, and any error will be corrected.
- e) Ladino Dairy Farm Dean Adams reported, through Mr. Hayden, that a report will be forthcoming at the next meeting of the Board.

10. Las Vegas Building Program

Dr. Wood suggested that a date be set for the dedication of plaques in the new building, together with an open house, and that at the same time a ground-breaking ceremony for the second building on the Campus be planned.

Motion by Mr. Elwell, seconded by Dr. Anderson, carried unanimously that the date for these ceremonies be set for Sunday, May 11, and that the next meeting of the Board of Regents be held on Monday, May 12, in Las Vegas.

11. Cornerstone - Student Building

Dr. Wood reported on plans for laying the cornerstone in the Jot Travis Student Union under the direction of the Masonic Order, as requested by the Board of Regents.

Motion by Mr. Thompson, seconded by Mr. Hardy, carried unanimously that the date for laying the cornerstone be set for Sunday, May 18.

12. Off-Campus Instructional Centers

Dr. Wood reported on his trips to Ely and Elko to meet with the Boards of Education in regard to off-campus instructional centers of the University of Nevada, and presented the following report:

As a means of improving University services throughout the year to the residents of Northeastern Nevada and to the residents of Eastern Nevada, the following plan, to be initiated at the beginning of the next academic year on an experimental basis, is proposed.

PART ONE

- That the University through its Statewide Development Program provide a limited number of University level Freshman courses in late afternoons, evenings and Saturday mornings both in Elko and in Ely.
- That Instructors in such courses be provided either by qualified school teachers with Master's degrees, or by other comparably qualified residents of the community concerned.
- 3. That the program to be offered in this manner during the 1st semester of 1958-59 include such courses as the 2 non-credit refresher courses, English A and Mathematics A, and the credit courses, English 101, "Composition and Rhetoric" (3 credits), History 101, "United States History" (3 credits) or History 105, "European Civilization" (3 credits), Mathematics 101, "Intermediate Algebra" (2 credits)

or Mathematics 110, "College Algebra" (3 credits), Political Science 101, "American Government" (3 credits), and Speech 111, "Public Speaking" (2 credits).

It should be noted that these courses are general requirements for graduation in most programs of study offered by the University.

- 4. That a definite limitation of not more than 1 full year of University work be placed upon the total amount of University credit acceptable at the University of Nevada or recommended for transfer elsewhere that could be earned by a student at Elko or at Ely.
- 5. That a limitation of not more than 1 course per semester, in addition to regular school assignments, be placed on the overload that a qualified school teacher would be permitted to carry, and this only with the express approval of the principal and superintendent concerned.
- 6. That at least once each semester the University arrange to have the Chairman of the Department in which the particular course is offered on the Reno Campus visit each class offered through the Statewide Development Program in Elko and in Ely, and that the school, or other, Instructors be invited and encouraged to meet, if possible, with the members of the Department at least once each semester on the Reno Campus.
- 7. That the credentials of the school teachers, or others, who would serve as Instructors be reviewed and approved by the Chairman of the Department and the Dean of the College concerned prior to their appointments to handle the University assignment.
- That arrangements be made with the public school officials in Elko and in Ely to provide the necessary facilities for the class work at times that would not interfere with their regular secondary school program.
- That Instructors be paid on the same basis as other Instructors in the Evening Division and Off-Campus Program.

- That the students taking the courses be charged the usual part-time fee of \$10 per credit, or equivalent, for non-credit courses.
- 11. That the University of Nevada assume responsibility for the administrative overhead costs and for providing an adequate supply of reference materials which may not be available in either the public or secondary school libraries in Elko and in Ely.
- That the Board of Regents, as well as the Boards of Education of Elko County and White Pine County, approve the proposed arrangement prior to its initiation.
- That the Board of Regents of the University of Nevada officially designate Elko and Ely as "University of Nevada Regional Off-Campus Instructional Centers".

PART TWO

It is further proposed that on an experimental and limited basis such University-level Freshman courses be open to honor roll students in their senior year of high school, upon approval of their principal.

If this plan were adopted, it should serve as a stimulus to the able student and make possible either an earlier completion of University work or an opportunity to do more advanced work or carry a broader program of studies while at the University. The high school senior would carry the College-level course in addition to his regular high school program.

Credit earned would apply, not toward graduation from high school or admission to College, but toward graduation from the University. Grades earned in the course would be authenticated by a standardized examination, such as the "Advanced Placement Examinations" or the "Sequential Tests of Educational Progress".

The fees to be paid for each course would be the same as those paid by all other University part-time students, \$10 per credit.

The student would not be able to take more than a one

such course per semester, with a total limitation of 6 to 8 credits.

It is probable that not more than a dozen such honor students would be interested in participating in such a program at Elko or at Ely next year.

It is suggested that the proposed experiment be given a trial at Elko and at Ely, beginning next September, if appropriate arrangements can be made.

Motion by Mr. Sawyer, seconded by Mr. Elwell, carried unanimously that Dr. Wood be authorized to carry out the program as proposed, and that an annual report be made to the Board of Regents.

The Board recessed at 12 noon for luncheon.

The recessed meeting was called to order at 2 P.M. by the Chairman. Regents Anderson and Sawyer had a luncheon engagement and returned at 2:50 P.M.

13. Surplus Property

Mr. Hayden requested formal action authorizing him to sign for the University in placing orders to the Nevada State Surplus Property Division. This authorization is required by the General Accounting Office of the U. S. Department of Health, Education and Welfare.

Motion by Mr. Thompson, seconded by Mr. Hardy, carried unanimously that the following resolution be adopted:

RESOLVED, that the Comptroller of the University of Nevada is hereby authorized to sign requisitions and purchase orders for surplus property from the State Surplus Property Division.

14. Indian Agency Contract

Mr. Hayden requested formal action authorizing the President to sign, on behalf of the University, the contract and amendments to the contract which the University has with the Nevada Indian Agency for the Economic Study of Pyramid Lake.

Motion by Mr. Broadbent, seconded by Mr. Hardy, carried unanimously that the following resolution be adopted:

RESOLVED, that the President of the University of Nevada is hereby authorized to sign the contract, and any amendments, between the Bureau of Indian Affairs, and the University of Nevada for the Economic Study of Pyramid Lake.

15. Leave and Health Examination Policies

Dr. Wood proposed that a committee be set up to study and propose a policy concerning sick leave, annual leave, terminal leave, health examination and related matters.

Motion by Mr. Hardy, seconded by Mr. Elwell, carried unanimously that the President be asked to set up a committee from members of the professional staff to study these policy matters, and to make recommendation to the Board of Regents.

16. Desert Research Institute

Meetings have been held with the Western Nevada Development group and similar interested groups, and considerable interest has been indicated. A report will be presented to the Board of Regents at the next meeting.

17. Building Program

Engineer Rogers presented and discussed the following items of the University Building Program:

a) Married Housing Units - Architects Ferris and Erskine were present to discuss plans for the married housing units on the site originally selected for the project. Mr. Erskine explained the details of the newly designed units, which bring the cost within the budget. On the basis of the plans and the explanation given by the architect, Dr. Wood recommended tentative approval with authority to present the plans to the Building Committee of the Regents when the drawings are ready for final approval.

Motion by Mr. Hardy, seconded by Mr. Elwell, carried unanimously that the preliminary plans be approved, and that the architects be authorized to proceed with the drawings for presentation to the Regents Building Committee for final approval, and then for submission to the Federal Housing and Home Finance Agency.

b) Fine Arts Building - Each Department which will be housed in the building has gone over the plans carefully and has reported back to the University Engineer, with suggestions and recommendations. These were forwarded to the architects. The changes have been made and have been approved by the Departments concerned. The plans are within the budget.

Motion by Mr. Thompson, seconded by Mr. Hardy, carried unanimously that the preliminary plans be approved for the Fine Arts building and that the University Engineer notify the architects to proceed with the drawings.

- c) Dining Hall and Men's Dormitory Plans are in the Finance Division of the Federal Housing and Home Finance Agency.
- d) Las Vegas Building Final plans have been received, checked and forwarded to the Las Vegas staff for checking of details.
- e) Flood Control Preliminary plans are in the completion stage but have not been received at the University.

19. Summer Session Fees

Dr. Wood presented the recommendation from the Dean of the College of Education, and approved by the Academic Committee for increase in Summer Session fees to bring them in line with part-time fees charged in regular session, as follows:

Resident - \$10 per credit for each term or session, and laboratory fees, if any Non-Resident - \$12 per credit for each term or session, and laboratory fees, if any

Motion by Dr. Anderson, seconded by Mr. Thompson, carried unanimously that the recommendation be approved, and Summer Session fees set accordingly.

20. University as Voting Place

Dr. Wood read a letter from Mr. Brown, County Clerk, requesting the use of the University Gymnasium as a polling place in the forthcoming primary election. There was some discussion as to the best place on the Campus for such activity, if the request were to be granted, and of parking and other difficulties involved.

Motion by Mr. Sawyer, seconded by Mr. Thompson, carried unanimously that the University Administration be authorized to make the facilities of the University available to the County Clerk for voting purposes, if satisfactory arrangements can be worked out.

21. Campus Traffic

Mr. Rogers discussed the traffic dangers on the main thoroughfare through the Campus and in line with the traffic code previously approved by the Board of Regents. He proposed to make a limited access road of the area between Stewart Hall and just above the Education building. Approval was confirmed.

22. North Virginia Street Traffic

Mr. Hardy discussed traffic dangers at North Virginia and Ninth Streets, which is without control at the present time.

Motion by Mr. Hardy, seconded by Mr. Thompson, carried unanimously that the Reno City Council be requested to in-

stall stop lights or blinkers at this intersection, as a safety measure.

23. Faculty Organization

Copies of an Organization Plan for the Professional Staff of the University, submitted by the Organization Committee of the Faculty Forum, had previously been placed in the hands of the Regents. Mr. Grant asked that each Regent study the Plan carefully before action is taken.

Motion by Dr. Anderson, seconded by Mr. Hardy, carried unanimously that a committee of the Board of Regents be appointed to discuss the proposed Organization Plan with the University Administration and report back to the Board.

Chairman Grant appointed Regents Thompson, Chairman, Hardy, Anderson, Lombardi to serve as the committee, and asked that other members of the Board submit suggestions to the Secretary of the Board concerning the Organization Plan.

24. Regents Committee on the College of Education

Mr. Thompson reported that the Committee has not completed its work, but will have a report ready for the next meeting.

25. Russian Language Courses

Regent Anderson suggested that the matter of teaching the Russian language at the University of Nevada be referred to the Faculty Committee on Curriculum, and if found desirable, that such courses be included in the curriculum as soon as feasible.

26. Gas Distribution System

Regent Thompson discussed the gas distribution system on the Campus. During the past year the Sierra Pacific Power Company has been carrying on a study of the gas distribution system in Reno under procedures approved by the Public Service Commission. However, there is a line within the boundaries of the Campus which does not come under the jurisdiction of the Power Company or the Public Service Commission, and therefore, was not included in the Power Company study. It was noted that the University has been conducting a study and survey of the gas distribution system, using a local firm.

Motion by Mr. Thompson, seconded by Dr. Anderson, carried unanimously that the President of the University and the University Engineer be authorized to negotiate with the Sierra Pacific Power Company to see if any practical plan can be worked out whereby the Power Company would maintain the gas distribution system on the Campus.

27. Revenue Bond Buildings

Information was received from the Housing and Home Finance Agency that they were accepting applications for advance for public works planning, and requested that, if the University of Nevada were interested, a resolution be adopted to that effect. Oral recommendation of the Planning Board was received, and later confirmed in writing that "The State of Nevada Planning Board recommends the approval of the University of Nevada's request for an advance for a planning loan in the amount of \$51,671.00 for the purpose of providing complete working drawings and specifications necessary to the construction of 3 projects as specified in a previous application submitted by the University: a dormitory for men, a dining hall and married students housing." The following resolution was adopted unanimously and the President and the University Engineer were authorized to make formal application to the Housing and Home Finance Agency for the loan.

Resolution

WHEREAS, Board of Regents for the University of Nevada, herein called the "Applicant", after thorough consideration of the various aspects of the problem and study of available data has hereby determined that the construction of certain public works, generally described as Men's Dormitory, Married Housing, Dining Hall, is desirable and in the public interest and to that end it is necessary that action preliminary to the construction of said works be taken immediately; and

WHEREAS, under the terms of Public Law 560, 83rd Congress, as amended, the United States of America has authorized the making of advances to public bodies to aid in financing the cost of engineering and architectural surveys, designs, plans, working drawings, specifications or other action preliminary to and in preparation for the construction of public works; and

WHEREAS, the Applicant has examined and duly considered

such Act and the Applicant considers it to be in the public interest and to its benefit to file an application under said Act and to authorize other action in connection therewith:

NOW, THEREFORE, BE IT RESOLVED by the Board of Regents for the University of Nevada, the governing body of said Applicant, as follows:

- That the construction of said public works is essential to and is to the best interests of the Applicant, and to the end that such public works may be provided as promptly as practicable, it is desirable that action preliminary to the construction thereof be undertaken immediately;
- 2. That William R. Wood, Acting President, be hereby authorized to file in behalf of the Applicant an application (in form required by the United States and in conformity with said Act) for an advance to be made by the United States to the Applicant to aid in defraying the cost of plan preparation for the above described public works, which shall consist generally of Men's Dormitory, Married Housing, Dining Hall;
- That if such advance be made, the Applicant shall provide or make necessary arrangements to provide such funds, in addition to the advance, as may be required to defray the cost of the plan preparation of such public works;
- 4. The said William R. Wood, Acting President, is hereby authorized to furnish such information and take such other action as may be necessary to enable the Applicant to qualify for the advance;
- 5. That the officer designated in the preceding paragraph is hereby designated as the authorized representative of the Applicant for the purpose of furnishing to the United States such information, data and documents pertaining to the application for an advance as may be required; and otherwise to act as the authorized representative of the Applicant in connection with this application;
- 6. That certified copies of this resolution be included as part of the application for an advance to be sub-

mitted to the United States.

The meeting adjourned at 4:30 P.M.
