> REGENTS MEETING March 1, 1941

Meeting called to order by Chairman Ross at 9:30 A.M., members present: Judge Brown, Mrs. Wardin, Dr. Olmsted and Mr. Ross.

Regents approved Regents Checks on List No. 8 as follows, 01-101 to 01-116 for a total of \$53,000.55 and State Claims, List No. 8, 01-149 to 01-171.

Mr. Ross moved that the minutes of the January 30, 1941 meeting be approved. Passed.

Mrs. Wardin suggested that an invitation be extended by the President to Miss Sissa and Miss Beckwith and others who are away from the University to attend the Commencement celebration.

Dr. Hartman told the Regents about the cannon to be given the University from the Mackay Estate if University provides transportation. Regents decided to wait until more information was available.

On recommendation of Dr. Hartman the Regents authorized Mr. Ross to sign the proxy for Standard Brands stock for the Board.

Dr. Hartman presented a letter from the Nevada Star Grange, which desires to purchase land from the University Farm for a meeting hall for the Grange. Mr. Ross recommended that the land be given

them for a small fee if the Legislature will give its consent. The President and Mr. Gorman, with the representatives of the Farm Bureau, are to take the matter up before the Legislature.

Dr. Hartman read a letter from Mrs. Jane Clark offering the Regents the property along the Western Pacific railroad as a gift. Dr. Hartman also read a letter from Harlan Johnson on behalf of property owners on University Heights, concerning this same piece of property along the railroad formerly owned by Mrs. Clark, in which they offered the University the property. Mrs. Clark is to deed the property to the University, the property having been paid for by the group of property owners on the Heights. Mrs. Wardin moved that the property be accepted and letters be writen to those concerned thanking them.

Dr. Hartman asked for an expression of opinion from the Board as to whether or not he should send information about bids to inquiring parties. It was the opinion of the Regents that anyone was free to come when the bids were opened and have a representative present but that the President is not obligated to send out information.

Mr. Ross suggested that the President let Mr. Sibley know about the policy of the Board in the past with regard to faculty members who are ill - salary continues.

Dr. Hartman read a letter from S. B. Doten concerning the purchase of Dania Hall by the negro church, in which he suggested that the University purchase the hall for use as a storehouse for valuable Experiment Station records. Dr. Hartman expressed his opinion that the University could take no part in the matter of the negroes renting the hall. Judge Brown stated that the University had no legal right to participate in the affair from the University point of view but that as individuals they could do what they pleased.

Bids on the new Gymnasium were opened at this time. Meeting adjourned at 12 noon to await tabulation of the bids.

Meeting reconvened at 3 P.M. at which time the following bids were considered:
