EXECUTIVE COMMITTEE MEETING August 24, 1953

The Executive Committee of the Board of Regents met in the President's office at 4 P.M. on Monday, August 24, 1953, for the purpose of opening bids. Present: Regents Ross and Hardy, President Stout and Comptroller Hayden. Regent Lombardi was unable to be present because of pressure of work in his office. Mr. Hayden presented copies of the notices which had duly appeared in the local papers.

On August 25, 1953, the bids for the remodeling work in the Mackay School of Mines, having been checked and studied by Mr. Hayden and Mr. Lockard, the members of the Executive Committee were polled by the Secretary. The decision was unanimous that the bid be awarded to the lowest bidder, Mr. R. E. Hansen, in the amount of \$40,530.00, and that the checks and bonds accompanying the other bids be returned.

Also on August 25, 1953, the bids for the painting of Lincoln Hall, having been checked and studied by Mr. Hayden and Mr. Horn, the members of the Executive Committee were polled by the Secre-

tary. The decision was unanimous that the bid be awarded to the lowest bidder, Mr. Dave Benson, in the amount of \$1,081.00, and that the checks and bonds accompanying the other bids be returned.
