March 17, 1906

The Board of Regents met at their Office in Morrill Hall building at 10 o'clock A.M., March 17, 1906. Present Regents Oscar J. Smith, W. W. Booher and H. S. Starrett, and Joseph E. Stubbs, President of the University.

Minutes of February 3, 1906 read and approved.

Upon motion of Regent Booher, seconded by Regent Starrett, Professor L. W. Cushman was granted a sabbatical leave of absence for one year, to take effect September 1, 1906, on half pay.
