Upon the recommendation of President Clark, the following in-

H. E. Higgins from general funds, \$200 for instruction during the months September to April inclusive, in addition to the regular salary of \$2400 from State Mining Laboratory funds

A. E. Turner, from \$2750 to \$3000
Miss Riegelhuth, from \$2400 to \$2700
S. C. Feemster, from \$2250 to \$2500
F. H. Sibley, from \$3750 to \$4000
C. H. Kent, from \$2250 to \$2500
Miss Sameth, from \$2400 to \$2700
Miss Somers, from \$2100 to \$2250 and an Assistant Professorship
G. B. Blair, from \$2250 to \$2500

Judge Talbot	Aye, excepting the vote of \$2500 to Miss Sissa as being too large a proportional increase under present conditions of lowered price tendencies, and excepting any increase at this time to Professors Sears and Turner, as they have already been increased within the year. The Judge does

not wish to go on record as being against increases, but merely as against increases being granted too frequently.

Regent Pratt withdrew.

President Clark read a letter of appreciation from the Washington office of the Veterans' Bureau thanking this University of Nevada for waiving its entrance requirement in the case of Veterans' Bureau men.

President Clark recommended the appointment of Samuel B. Doten as editor of a history of the University to be prepared and ready probably for distribution at the semi-centennial celebration of this University in 1924. Mr. North made the motion.
